1. Prospective tenderers / bidders are requested to inspect the vehicles and convince themselves of its condition before submitting the tender or taking part in the tender-cum-auction. The company will not entertain any complaint regarding the condition of the vehicle after the tender-cum-auction.
2. The Vehicles are available for inspection at the Registered Office of the Company at Punalur during the office hours i.e. from 9.30 a.m to 5.00 p.m on all working days . The Company will not be using the vehicle during the period from the tender date till its confirmation except starting the same for few minutes in order to maintain the condition of the battery.
3. Those intending to participate in the tender-cum-auction should submit their offer along with an **Earnest Money Deposit** for each vehicle by Demand Draft along with tender-cum-auction conditions signed on all pages before **2 P.M on 05/12/2017** and obtain their passes for participating in the auction. The offers of those tenderers without EMD will not be accepted and those who failed to deposit EMD will not be admitted to the auction hall to take part in the auction.
4. The auction will commence at 2.30 p.m on 05/12/2017. The tenders received as per clause (3) will be opened immediately after the auction. The highest amount obtained in the tender or in the auction will normally be confirmed in the name of that person. However the Managing Director of the Company has absolute discretion in accepting or rejecting any offer without assigning any reason and his decision will be final.
5. The highest bidder or tenderer has no right to withdraw his offer without the written permission of the company.
6. The GST 28% and other taxes if any, at rates applicable at the time of remittances of offered value, will have to be paid extra by the purchaser. The price quoted should be exclusive of taxes.

7. The highest tenderer/ bidder shall have to remit 1/3<sup>rd</sup> of the sale value immediately after the tender-cum-auction and the balance value including taxes within 7 days of **the date of receipt of confirmation from** the company. In case of failure to remit **value as aforesaid**, the EMD of that highest tenderer/bidder will be forfeited and the vehicle will be sold at his risk and cost, without any notice. Further the defaulter will be black listed by the Company.
8. The EMD's of all other bidders will be released immediately after remittance of 1/3<sup>rd</sup> value by highest bidder.
9. In case of failure by the highest bidder to remit 1/3<sup>rd</sup> value as per clause (7) above, the company has the right to request the second highest bidder/tenderer to remit value as stipulated in clause (7) and without prejudice to it.
10. On issue of acceptance of the offer by way of confirmation letter by the Company to the successful bidder, the contract shall be deemed to be concluded.
11. The purchaser will have to remove the vehicle within 7 days of the date of **receipt of acceptance order/confirmation letter from the company as per clause '7'** at his own cost, failing which the items will be sold at the purchaser's risk. Short receipt of value of vehicle, if any, and all other expenses incurred by the Company in connection with the resale including advertisement charges if any shall be borne by the defaulted contractor. Defaulted contractor shall not be eligible for amount, if any, received in excess of the original tendered price.
12. Special conditions, if any, attached with the tenders will not be applicable to the sale unless they are accepted in writing by the company.
13. In case the rate quoted in tender and the bid amount are equal, the decision of the Managing Director regarding the successful purchaser will be final.
14. The purchaser shall obtain the transfer of ownership of the vehicle items before putting in to use.
15. The purchaser has to arrange for insurance and any other taxes of the items at his own cost from the date of confirmation of sale and the copies of these documents have to be filed with the company while taking delivery of the vehicle.
16. The purchaser shall comply with the relevant rules in force before the vehicle is taken delivery from the company.
17. Any disputes that may arise with this tender-cum-auction shall be referred to the Court of Punalur which alone shall have jurisdiction.
18. In case the notified tender-cum-auction date happens to be a holiday the tender-cum-auction will be conducted on the next working day at the appointed time and venue.
