**TERMS AND CONDITIONS ATTACHED TO THE NOTIFICATION**  
**FOR PURCHASE OF CHINA CLAY**

1. Limited tenders are invited for the supply of China clay at L C Factory at Kulathupuzha of the company.
2. Last date for receiving the tender is 26.07.2018 at 2pm. Tender will be opened on the same day at 3pm. Intending tenderers have to sign the tender conditions and submit along with tender. Cost of tender form ₹ 400/-+18% GST=₹ 472/-Tenders without sufficient cost of tender form cost will be rejected.
3. Rate quoted should be inclusive of GST, transportation, loading & unloading charge etc for delivery at Factory complex..
4. All the intending tenderers will have to furnish 1% of the quoted rate as Earnest Money Deposit.
5. Materials supplied should conform to the specification given below:

6. The Managing Director of the company reserves the right and power to accept or reject any tender without assigning any reason.
7. The Earnest money deposit will be refunded within one week of finalization of the contract to all whose offers have not been accepted.
8. The Contract will be concluded on issue of Purchase order by the Company. The tenderer whose offer has been accepted will have to enter into a formal written

agreement with the company for supply of chemicals as per the terms and conditions fixed by the company within 7 days of issue of the purchase order, failing which the EMD is liable to be forfeited and the purchase will be effected at the risk and cost of the Bidder whose offer has been accepted. Addresses for communications with Pin code and telephone number should be given by the intending Bidders.

9. The supplier should guarantee that the minimum required ingredients are included in the bulk supply of each item. ie, the material supplied should conform to the specification of the same.
10. Sampling & analysis: After delivery of the material by the supplier, three representative samples of the material shall be drawn (100 gms each) in the presence of the supplier's representative and company's representative. The sample should be labeled as sample No.1, No.2 & No.3 with the signature and date of the supplier's representative and company's representative. The samples will be packed in polythene bags. The 1<sup>st</sup> sample will be tested in the QC laboratory of the Company or at the approved testing laboratories against specifications. The 2<sup>nd</sup> sample is given to the supplier and the III<sup>rd</sup> sample will be kept under the custody of the company. In case of any dispute the III<sup>rd</sup> sample will be reanalyzed and this result will be binding on both the parties.
11. Billing will be done by the supplier and should be sent to the Manager Factory Complex of the company. Payments will be made only after receiving Store receipt note & Quality acceptance report from the Manager, Factory Complex. All payments will be made by Account payee cheques /NEFT.
12. The rate quoted should be firm till the company accepts the same. No representation for enhancement of rates once accepted will be considered on any account.
13. Billing should be done as per GST requirements .
14. The supply of materials should be as per specifications and as per purchase order issued by the Company. If the supplier fails to supply the articles within the time frame as per specifications, arrangements will be made to get the materials from other sources at the risk and cost of the supplier and the difference in cost including the advertisement charges and other expenses, if any, will have to be borne by the defaulted contractor and the same will be recovered through legal means/Revenue Recovery Proceedings/from any other amount due to the contractor from the Company.
15. The security deposit will be forfeited in case of any breach of contract, by the contractor. In case there is no liability, the security deposit will be released after the supply is completed and after getting the non-liability certificate from the respective Manager.

16. The Managing Director of the company has the right to terminate the contract by giving 15 days notice & to extend the supply period up to 2 years on mutual agreement with the same terms and conditions.
17. Special conditions, if any, written on the tender or attached with the tender will not be applicable to the contract unless they are expressly accepted by the Company in writing.
18. The quantity of the articles specified in the present requirement is subject to variation according to the requirements at the time of Purchase.
19. The supplier must also enclose a test report of the material supplied at the time of delivery.
20. The material safety data sheet (MSDS) of product supplied must be enclosed wherever applicable.
21. Specific mention must be made if the product supplied contains any toxic/ environmentally hazardous material.
22. The Bidder agrees that time wherever specified is the essence of the contract.
23. If the date of tender happens to be a holiday, the tender will be opened on the next working day.
24. Transporting vehicles should carry TREM CARD if required.
25. Any dispute arising out of this contract, all suits or other legal proceedings in connection with any of the matter regarding the supply shall be instituted in the Court at Punalur only.
