## TENDER CONDITIONS ATTACHED TO THE E-TENDER NOTICE FOR THE PURCHASE OF L.C.MACHINES

1. E-tender is invited for the supply erection, testing, commissioning and testing of centrifuging machines at L C Factory, Kulathupuzha estate of the company as detailed below.

- 2. Last date and time for uploading the tender in the e-tender site is 5 pm on 15.05.2021. The offer will be opened at 11 am on 18.05.2021. Every intending bidder has to sign the conditions on each page in token of having accepted the same and upload the same.
- 3. Tenderer should be the manufacturer / authorized dealer. Letter of Authorization from original equipment manufacturer (OEM) specific to the tender should be enclosed.
- 4. The rates quoted in the tender must be inclusive of all taxes, machine demonstration, loading & unloading, transport insurance (wherever applicable) and transportation charges to deliver the equipment/machine at L.C. Factory, Kulathupuzha Estate. All the intending bidders will have to furnish tender form cost for complete set of Latex Centrifuging Separator (₹17400+18% GST) and Spare Bowl for LRB 810 Machine (₹3000+18% GST). Earnest Money Deposit of 1% of the total quoted rate to be remitted through on line facility. Exemptions, if any, will be allowed as per government order on production of documentary evidence. Rate breakup details and Bidder details should be uploaded separately in the attached format.
- 5. The successful tenderer should supply machines within 90 days of placing the purchase order.
- 6. The contractor has to set up and demonstrate equipment before that the delivery would not be deemed to be complete.

- 7. The tenderer should sign (not initials) at each page of the tender conditions. No page should be removed/ detached from the tender document.
- EMD in respect of tenderer whose offer has been accepted will be retained and adjusted as
  part of the security deposit for due performance of the contract. Contract should be
  concluded and binding on issue of purchase orders by the Company.
- 9. The contractor is required to do the installation and demonstration of the equipment within two weeks of the arrival of machines at L.C. Factory, Kulathupuzha Estate, site of installation, otherwise the penalty clause will be the same as per the supply of materials.
- 10. In case of any damage to machines and supplies during the carriage of supplies from the origin of machines to the installation site, the contractor has to replace it with new machines/supply immediately at his own risk. The company will not be liable to any type of losses in any form.
- 11. The 80 % payment will be released after delivery of machines and spare bowl as per the specification in good condition, successful commissioning, installation, testing of machines or equipment.
- 12. The remaining 20% payment will be released after satisfying all the conditions as per the tender terms and condition, satisfactory functioning of the machines/equipment supplied and after furnishing of Guarantee/ Warranty documents and the security deposit.
- 13. The successful tenderer need to remit the security deposit (5 % of the final price /contract value of the machine) which should be valid for a period of 90 days beyond the completion of all contractual obligations of the contractor including warranty. In case there is no liability, the security deposit will be released after getting the non-liability certificate from the respective Manager based on the certificate.
- 14. The security deposit shall be forfeited and credited to the company in the event of breach of contractual obligation by the contractor, in terms of relevant contract.
- 15. The Managing Director of the company has the right to terminate the contract by giving 15 days notice.
- 16. The company shall promptly notify the Contractor in writing of any claims arising under this warranty. Upon receipt of such notice, the Contractor shall arrange to repair or replace the defective goods or parts within 7 days free of cost in L.C. Factory, Kulathupuzha Estate. The Contractor shall take over the replaced parts/goods at the time of their replacement. No claim whatsoever shall lie on the company for the replaced parts thereafter. The period for correction of defects in the warranty period is 03 days. If the contractor having been notified fails to remedy the defects within 03 days, the company may proceed to take such remedial action as may be necessary, at the risk and loss of the contractor and expenses and without prejudice to any other rights, which the company may have against the contractor.
- 17. If the supplier defaults in the supply of all or any of the articles correctly and promptly as above, as per the specifications of the Company, the Company is at liberty to procure the same from elsewhere without cancelling the contract as a whole. If the company incurs in this procuring such materials at a higher cost than the agreed rate, such excess cost shall be deducted by the company from the supplier's bill or adjusted or otherwise realized from his

security deposit or recovered from him by legal means including Revenue Recovery proceedings along with all expenses incurred in the alternate purchase including advertisement cost & @10% of administrative expenses as finalized by the Company. If supplier violates the conditions of the contract, if needed the company will blacklist the defaulted supplier from participating in any work of the company.

- 18. The warranty period should be clearly mentioned. The maintenance charges (AMC) under different schemes after the expiry of the warranty should also be mentioned. The comprehensive warranty will commence from the date of the satisfactory installation/commissioning of the equipment against the defect of any manufacturing, workmanship and poor quality of the components.
- 19. After the warranty period is over, Annual Maintenance Contract (AMC)/Comprehensive Maintenance Contract (CMC) up to next two years should be started. The AMC/CMC charges will not be included in computing the total cost of the equipment.
- 20. If the date of tender happens to be a holiday, the tender will be opened on the next working day.
- 21. Bidder agrees that time wherever specified is essence of the contract
- 22. If any of the machines or its parts supplied by the contractor is found to be substandard, refurbished, un-merchantable or not in accordance with the description/specification or otherwise faulty, the company will have the right to reject the machines or its part. The prices of such machines or its parts shall be refunded by the contractor with 18% interest if such payments for such equipment have already been made.
- 23. Defective part in machines, if found before installation and/or during warranty period, shall be replaced within 7 days on receipt of the intimation from this office at the cost and risk of contractor including all other charges.
- 24. The contractor should ensure that the claimed efficiency parameters of the machines are achieved after commissioning.
- 25. Special conditions, if any, written on the tender or attached with the tender will not be applicable to the contract unless they are expressly accepted by the Company in writing
- 26. Any dispute arising out of this contract, all suits or other legal proceedings in connection with any of the matter regarding the supply shall be instituted in the Court at Punalur only.
