## TERMS AND CONDITIONS ATTACHED TO THE NOTIFICATION FOR SUPPLY OF SAW DUST BRIQUETTES

- 1. E-tenders are invited for the supply of **saw dust briquettes** for use in the Gassifier at Latex Centrifuging Factory at Kulathupuzha and having following **specifications**: Size: 60mm dia, calorific value: 4000-4500 kcal/kg, Moisture 10% maximum.
- 2. Last date and time for uploading the tender in the e-tender site is **5 pm on 09.07.2021.** The offer will be opened **at 11 am on 14.07.2021**. Every intending bidder has to sign the conditions on each page in token of having accepted the same and upload the same.
- 3. Rate quoted should be inclusive of G.S.T, transportation, loading & unloading charge etc and for the delivery at L.C. Factory at Kulathupuzha estate of the company. Delivery schedule is as per the requirement from the Manager, Factory Complex.
- 4. All the intending bidders will have to furnish **tender form cost** ₹1030+18% **tax** = ₹1215/- and Earnest Money Deposit of ₹5525/- through on line facility. Exemptions, if any, will be allowed as per government order on production of documentary evidence.
- 5. The Earnest money deposit will be refunded automatically through electronic means within one week of finalization of the contract to all whose offers have not been accepted.
- 6. The Contract will be concluded on issue of Purchase order by the Company. The tenderer whose offer has been accepted will have to enter into a formal written agreement with the company for supply of Saw dust Briquettes as per the terms and conditions fixed by the company within 7 days of issue of the purchase order, failing which the EMD is liable to be forfeited and the purchase will be effected at the risk and cost of the Bidder whose offer has been accepted.
- 7. The successful bidder should furnish security deposit @ 5% of the total purchase value for the due performance of the contract after having accepted the tender by the company and before executing agreement.
- 8. Billing will be done by the supplier as per GST requirements and should be sent to the Managing Director/ respective Managers of the Company. Payments will be made within 45 days after receiving quality certificate and stock certificate from the Manager. All payments will be made by Account payee cheques /NEFT.
- 9. The rate quoted should be firm till the company accepts the same. No representation for enhancement of rates once accepted will be considered on any account.
- 10. The Managing Director of the Company reserves the right and power to accept or reject any tender without assigning any reason.
- 11. The supply of materials should be as per specifications and supply schedule in the purchase order issued by the Company. If the supplier fails to supply the articles within the time frame as per specifications, arrangements will be made to get the materials from other sources at the risk and cost of the supplier and the difference in cost including the advertisement charges and other expenses, if any, will have to be borne by the defaulted contractor and the same will be recovered through legal means/Revenue Recovery Proceedings/from any other amount due to the contractor from the Company. The defaulted contractor will not be eligible for any such amount if the rate received in the alternate arrangement is less than the rate given by the defaulted contractor.
- 12. The Security deposit will be forfeited in case of any breach of contract, by the contractor. In case there is no liability, the security deposit will be released after the supply is completed and after getting the non-liability certificate from the respective Manager.

- 13. The Managing Director of the company has the right to terminate the contract by giving 15 days notice. The contract may be renewed up to 2 years on mutual agreement with the same terms and conditions, if needed.
- 14. Special conditions, if any, written on the tender or attached with the tender will not be applicable to the contract unless they are expressly accepted by the Company in writing.
- 15. The quantity of the articles specified in the present tender is subject to variation according to the requirements at the time of Purchase.
- 16. The supplier must also enclose a test report of the material supplied at the time of delivery.
- 17. The Material Safety Data Sheet (MSDS) of product supplied must be enclosed wherever applicable. Specific mention must be made if the product supplied contains any toxic/environmentally hazardous material. Transporting vehicles should carry TREM CARD if required.
- 18. The Bidder agrees that time wherever specified is the essence of the contract.
- 19. While entering to the estate & factory the transporter of the supplier should conform the Do's and Don'ts in the estate and factory.
- 20. If the date of tender happens to be a holiday, the tender will be opened on the next working day.
