- 6. Only one member from a family (family consists of husband, wife and children) is eligible for participating in the tender.
- 7. Company will provide the building, available furniture and utensils, fridge, water and light fittings for the purpose, free of charge. The licensee shall have to bring furniture, crockery and other required utensils, fuel etc for running the canteen.
- 8. A biogas plant is installed for processing the food waste. All the waste should be properly sorted out and fed into the biogas plant. The gas output can be utilized by the licensee at free of cost. Its operational details shall be collected from the canteen committee.

- 10. The licensee shall arrange to prepare meals and other refreshment items as per attached schedule and supply to the employees of the company at the rates quoted by licensee and approved by the company. This approved rate is applicable to all persons taking food from the canteen .The approved rate will be firm throughout the license period and no escalation will be allowed in the normal condition.
- 11. The items prepared by the licensee should be wholesome and price of items supplied should be as per schedule accepted by the company .The price accepted is to be exhibited in the canteen.
- 12. The person who is awarded with the contract for running canteen should be present in the canteen to ensure its smooth functioning during the contract period.
- 13. Canteen and its premises should be kept clean and hygiene by the licensee.
- 14. Canteen should be functioned by the licensee on all working days of the factory.
- 15. A committee called "canteen committee "consisting of employees of the factory will be formed to supervise the overall functioning to maintain hygiene of the canteen and to make suggestions regarding the menu. Any complaint from and against the licensee shall be addressed to the canteen committee for its redressel.
- 16. The licensee shall engage his own employees for the services at the canteen and shall produce medical fitness certificate for his employees in the canteen.
- 17. The Licensee shall obtain necessary certificate from the Panchayath for operating this contract.
- 18. The Management does not bind itself to accept the lowest or any tender and reserve the right to reject any tender.
- 19. An amount of Rs.1000/.is to be deposited as EMD along with the sealed tender without which the tender will not be considered.
- 20. The successful tenderer shall have to deposit a sum of Rs 15000/. free of interest as security deposit and execute an agreement with the company within a week from the acceptance of tender. The EMD of Rs 1000/. Will be adjusted in the security deposit.
