TENDER CONDITIONS ATTACHED TO THE E-TENDER NOTICE FOR THE PURCHASE OF HYDRAULIC BALING PRESS

 E-tenders are invited in two bid (Technical bid and Financial bid) for the supply of Single Chamber Hydraulic Baling Press at Crumb Rubber Factory, Kulathupuzha estate of the company as detailed below.

1	Scope of work	Supplying one number single chamber Hydraulic press of 10 Ton capacity and minimum 25 bales/hour.			
2	Duty	To compress dry rubber crumb in to bale of standard size and weight. The machine shall apply 100 Ton load on rubber.			
3	Chamber size	710 +/ 2 mm long and 360+/2mm wide and 600 mm deep			
4	Loading height	The top of chamber shall be at a height of 1250 mm (Approx) from the floor			
5	Material of construction	Baling Chamber Mild steel Ram – Mild steel bar ground and hard chromium plated.			
6	Controls	A centralized control panel for manual and automatic operation.			
7	Power pack	Motor 20 HP Energy efficient motor Make- ABB/Sharp/Alstem /Kirloskar Hydraulic Elements Make-Yuken/Prism/Danison/Polyhydron. Power pack shall be complete with all standard Accessories such as pressure gauge, pressure Relief valve etc. Oil shall be supplied for first filling.			
8	Cylinder	Main cylinder 2 nos- ID -200 mm Ram dia 140 mm			
9	Safety Features for the machine	Chamber side movement shall be activated only if the pressing plate is at the top. Ram down movement shall be activated only if the chamber is in pressing position. Ram movement shall be stopped at a particular position in the absence of rubber. A mechanical stopper shall be fitted to avoid any up movement of chamber.			

- 2. Last date and time for uploading the tender in the e-tender site is 5.00 PM on. 28.04.2022. The tender will be opened at 4.00 PM on 30.04.2022. Every intending bidder has to sign on each page of tender conditions (not initials) in token of having accepted the same and upload the same. No page should be removed/detached from the tender document.
- Tenderer should be the manufacturer. The necessary documents for the same should be enclosed.

- 4. The rates quoted in the e-tender must be inclusive of all taxes, machine demonstration, loading & unloading, transport insurance (wherever applicable) and transportation charges to deliver the equipment/machine at Crumb Rubber. Factory, Kulathupuzha Estate. All the intending bidders will have to furnish tender form cost for Hydraulic baling press (Rs.3540+18% GST) and Earnest Money Deposit of Rs.17700/- to be remitted through on line facility. Exemptions, if any, will be allowed as per government order on production of documentary evidence. Rate breakup details and Bidder details should be uploaded separately in the attached format.
- 5. The successful tenderer should supply Hydraulic Baling Press within 90 days of placing the purchase order.
- The contractor has to set up and demonstrate equipment before that the delivery would not be deemed to be complete.
- 7. The tenderer should have minimum 5 years manufacturing experience in The field of Hydraulic Equipments.
- 8. The tenderer should give the list of clients where this type of Hydraulic baling press supplied with similar specification.
- 9. The party should provide sufficient quantity of Hydraulic Oil (Grade 68) along with machine.
- 10. EMD in respect of tenderer whose offer has been accepted will be retained and adjusted as part of the security deposit for due performance of the contract. Contract should be concluded and binding on issue of purchase order by the Company.
- 11. The contractor is required to do the installation and demonstration of the Hydraulic baling press within two weeks of the arrival of machines at Crumb Rubber Factory. Factory, Kulathupuzha Estate, site of installation, otherwise the penalty clause will be the same as per the supply of machine.
- 12. In case of any damage to machines and supplies during the carriage of supplies from the origin of machines to the installation site, the contractor has to replace it with new machines/supply immediately at his own risk. The company will not be liable to any type of losses in any form.
- 13. The 80% payment will be released after delivery Hydraulic baling press as per the specification in good condition, successful commissioning, installation, testing of machines or equipment.
- 14. The remaining 20% payment will be released after satisfying all the conditions as per the tender terms and conditions, satisfactory functioning of the machines/equipment supplied and after furnishing of Guarantee/ Warranty documents and the security deposit.
- 15. The successful tenderer need to remit interest free security deposit (5 % of the final price /contract value of the machine) which should be valid for a period of 90 days

beyond the completion of all contractual obligations of the contractor including warranty period. In case there is no liability, the security deposit will be released after getting the non-liability certificate from the respective Manager after the prescribed period based on the certificate.

- 16. The security deposit shall be forfeited and credited to the company in the event of breach of contractual obligation by the contractor, in terms of relevant contract.
- 17. The Managing Director of the company has the right to terminate the contract by giving 15 days notice.
- 18. The company shall promptly notify the Contractor in writing of any claims arising under the warranty. Upon receipt of such notice, the Contractor shall arrange to repair or replace the defective goods or parts within 7 days free of cost in Crumb Rubber Factory, Kulathupuzha Estate. The period for correction of defects in the warranty period is 07 days. If the contractor having been notified fails to remedy the defects within 07 days, the company may proceed to take such remedial action as may be necessary, at the risk and loss of the contractor and expenses and without prejudice to any other rights, which the company may have against the contractor.
- 19. The contract will be concluded on issue of Purchase order by RPL.
- 20. If the supplier defaults in the supply of all or any of the articles correctly and promptly as above, as per the specifications of the Company, the Company is at liberty to procure the same from elsewhere without cancelling the contract as a whole. If the company incurs in this procuring such machine at a higher cost than the agreed rate, such excess cost shall be deducted by the company from the supplier's bill or adjusted or otherwise realized from their security deposit or recovered from them by legal means including Revenue Recovery proceedings along with all expenses incurred in the alternate purchase including advertisement cost & @10% of administrative expenses as finalized by the Company. If supplier violates the conditions of the contract, if needed the company will blacklist the defaulted supplier from participating in any work of the company.
- 21. The warranty period should be clearly mentioned.
- 22. If the date of tender happens to be a holiday, the tender will be opened on the next working day and no further notice will be issued in this regard.
- 23. Bidder agrees that time wherever specified is the essence of the contract.
- 24. If machine or its parts supplied by the contractor is found to be substandard, refurbished, un-merchantable or not in accordance with the description /specifications of the company or otherwise faulty, the company will have the right to reject the machine or its parts. The prices of such machines or its parts shall be refunded by the contractor with 18% interest if such payments for such equipment have already been made.
- 25. If any defective part in machine is found before installation and/or during warranty period, shall be replaced within 7 days on receipt of the intimation from this office at the cost and risk of contractor including all other charges.

- 26. Special conditions, if any, written on the tender or attached with the tender will not be applicable to the contract unless they are expressly accepted by the Company in writing.
- 27. Any dispute arising out of this contract, all suits or other legal proceedings in connection with any of the matter regarding the supply shall be instituted in the Court at Punalur only.
