CONDITIONS ATTACHED TO THE NOTIFICATION FOR REPAIR AND MAINTENANCE OF TUNNEL DRIER IN CRUMB RUBBER FACTORY

1. e-tenders in two covers (Separate Technical-Bid & Financial -Bid) are invited from interested parties for the Repair and Maintenance of Tunnel Drier at the Factory Complex of Rehabilitation Plantations Limited, Kulathupuzha. Last date & time for uploading the tender in the e-tender site is on 27.04.2022 at 5 pm and Tender will be opened on 30.04.2022 at 11 am.
2. Every intending bidder has to sign on the each page of tender conditions (not initials) in token of having accepted the same and upload the same. No page should be removed/ detached from the tender document. **In the Technical bid, the tenderer must upload the documentary evidences of past experience on Repair and Maintenance work of Tunnel Drier and signed tender conditions.**
3. Only Financial Bids of qualified Technical bids will be opened subsequently.
4. Financial Bid consists of BOQ
 - a. Tendered rate in BOQ should be all inclusive of GST
 - b. All the intending bidders will have to remit tender fee (Rs.524 + 18% GST and an Earnest Money Deposit of Rs. 5000/- through on line facility. Full Exemptions, if any, will be allowed as per government order by uploading necessary certificate and also exemption by part remittance of EMD according to the items quoted is possible by uploading details of the quoted items with EMD in the format attached.
5. Rate quoted should be for "**Repair and Maintenance of Tunnel Drier at CRF**" as mentioned in BOQ and as per drawings
6. The tenderers should inspect the drier before quoting the rate. Rate quoted should be including supply of spares, painting and any other unforeseen works.
7. GST or other taxes applicable should be shown separately. Otherwise the rate quoted will be taken as all inclusive.

8. The rate quoted should be firm for a minimum period of 3 months from the date of opening or till the Company accepts the same whichever is late. No representations for enhancement of rate once accepted will be considered on any account.
9. The contract will be concluded on issue of work order by the company.
10. EMD in respect of tenderer whose offer has been accepted will be retained and adjusted as part of the security deposit for due performance of the contract.
11. The tenderers whose offer has been accepted will have to enter into a formal agreement with the company for "**Repair and Maintenance of Tunnel Drier at CRF**" as per terms and conditions fixed by the company failing which the EMD is liable to be forfeited and works will be arranged at the risk and cost of the tenderer whose offer is accepted. The **Repair and Maintenance of Tunnel Drier at CRF** should be completed within three months of the date of confirmation work order.
12. The Managing Director of the company reserves the right to accept or reject any tender without assigning any reason.
13. The successful tenderer should furnish security deposit @ 5% of the total quoted value for the due performance of the agreement after acceptance of tender by the Company and execute agreement as per conditions.
14. Performance guarantee of the drier should be for a minimum period of one year.
15. Payment of bills will be made as below:
 - i. 75 % after successful completion of R & M as per the specifications of work by the company.
 - ii. Balance 25% after satisfactory trial runs for a minimum period (period of evaluation) of one month.

The security deposit as mentioned in clause (13) will be released only after the performance guarantee period, depending on no liability report from the concerned official.

16. The Repair and Maintenance of Tunnel Drierworks should be completed within the period specified in the work order of the Company. If the Contractor fails to complete work satisfactorily within the specified time, the Company reserves the right to make alternate arrangements from other sources at the risk and loss of the contractor. All expenses incurred in this alternative arrangement including 10% administrative expenses and the difference in cost on such arrangement etc. will be recovered from the defaulting contractor through legal means /revenue recovery proceeding. If the cost incurred in such alternate arrangement is less than that of the rate offered by the defaulted contractor he will not eligible for the reduction in rate.

17. The security deposit is liable to be forfeited in the event of any breach of contract by the contractor.
18. Special conditions, if any, written on the tender or attached with the tender will not be applicable to the contract unless they are expressly accepted by the Company in writing.
19. The tenderer whose offer has been accepted should guarantee that the completed work will conform to the work specified in the BOQ and as per the drawings.
20. The tenderer agrees that the time wherever specified is the essence of the contract.
21. The price preference for SSI/MSME Units as ordered by Government, if any, will be extended on production of evidence for the same.
22. All unserviceable items (spares replaced from machines) must be returned to the Factory, Kulathupuzha Estate.
23. The Company reserves the right to get the machinery and system evaluated and certified at appropriate agencies like Rubber Board, Kottayam etc. to ascertain the performance of the system.
24. The tenderer should specify whether it is a manufacturer/dealer/ordinary/MSME supplier.
25. Any dispute arising out of this contract, all suits or other legal proceedings in connection with any of the matter shall be instituted in the courts of Punalur only.

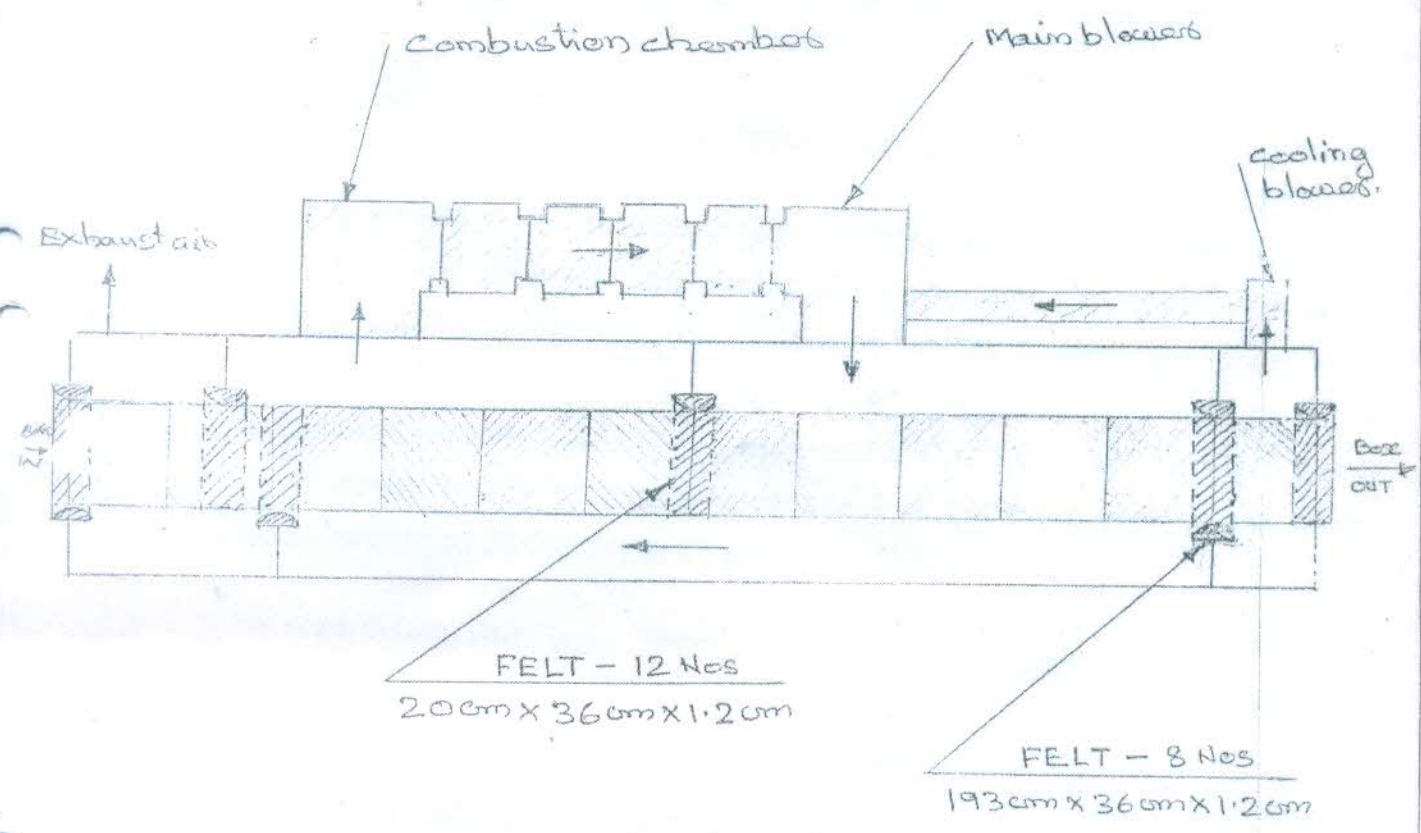
