## TERMS & CONDITIONS FOR THE RE-TENDER-CUM-AUCTION FOR THE SALE OF USED GASIFIER

Intending participants are requested to inspect the goods notified for sale. No complaints regarding quality will be entertained after the re-tender-cum-auction.
- 2. The participants should remit ₹5,000/- (Rupees Five Thousand only) either by demand draft in favour of 'Rehabilitation Plantations Limited' payable at Punalur or by NEFT/RTGS (A/C Details given below as EMD in the office before 25/11/2022 on 2.00 pm and the cash receipt obtained may be produced before the auctioning authority before commencement of the auction.

- 3. The rate offered should be the basic rate plus applicable GST should be paid by the contractor/bidder as applicable at the time of taking delivery.

The highest bidder should remit 1/3<sup>rd</sup> value including the EMD of the goods at the auction spot itself failing which the opportunity for remittance of the amount will go to the second highest bidder and the EMD remitted by the highest bidder will be forfeited. Balance 2/3<sup>rd</sup> value together with Tax as applicable should be remitted by the highest bidder/second highest bidder within seven days from the date of receipt of confirmation of sale failing which the 1/3<sup>rd</sup> value remitted and the EMD will be forfeited. The contract will be concluded on issue of order by the Company accepting the offer of the highest/second highest bidder as the case may be.

- 5. The EMD of other participants will be refunded on the same day itself after remittance of 1/3<sup>rd</sup> value as above by the highest bidder. EMD of the highest bidder/second highest bidder as the case may be, will be retained as Security Deposit and will be refunded after removing all the auctioned goods by the contractor.
- 6. The auctioned goods will have to be removed from the Factory premises within 15 days from the date of confirmation of the sale, failing which ground rent @ ₹50/- per day will be charged for the whole or part thereof. The auction will be conducted by the undersigned or by an officer authorized to do so, reserving the right to prevent any person from participating in the auction or to cancel the auction without specifying any reason for such prevention/cancellation.
- 7. No interest will be paid to the purchaser on the amount paid or deposited by him and subsequently found refundable to him under any of the conditions herein mentioned. The loading/cleaning charges etc. will be borne by the purchaser.
- 8. In case the above auction sale date falls on public holiday, the auction will be held on the next working day at the time and place specified above.
- 9. The contractor shall arrange the lifting of the material from its location and all the expenses for dismantling, loading/ transportation etc will be borne by the contractor.
- 10. The contractor/bidder should ensure that no damage or loss is caused to the company property/ while clearing the material and the contractor is liable for making such damage/loss and the liable amount will be deducted from the security deposit of the contractor and from other amount due to him or by other legal means. RPL (Company) will not be liable to any of them or for third party damages and the contractor alone will be held liable to those cases.
