TERMS AND CONDITIONS ATTACHED TO THE NOTIFICATION FOR PURCHASE OF COPPER OXY CHLORIDE

- 1. E-tender is invited for the supply of Copper oxy chloride for spraying in the Rubber Plantations of Kulathupuzha & Ayiranallur Estates of the company against the abnormal leaf fall/phytophthora disease incurred before the onset of south west monsoon.
- 2. Last date & time for uploading the tender in the e-tender site is 5 pm on 10.04.2023. The offers will be opened at 11 am on 12.04.2023. Every intending tenderer has to sign and upload the tender conditions token of having accepted the same.
- 3. Rate quoted should be inclusive of GST, transportation, loading & unloading charge etc. for the supply at Kulathupuzha Estate. For the supply at Ayiranallur estate, unloading expenses will be paid by the company and subsequently deducted from the supplier's bill. - 8. Earnest Money Deposit will be automatically refunded within one week of finalization of the contract to all those whose offers have not been accepted.
- 9. The contract shall be concluded on issue of purchase order by the Company. The tenderers whose offer has been accepted will have to enter into a formal written agreement with the company for supply of chemicals as per term and conditions fixed by the company within 7 days of the receipt of purchase order by the supplier failing which his EMD is liable to be forfeited and the purchase will be effected at the risk and cost of tenderer whose offer has been accepted.
- 10. The items supplied should be stacked as per instructions of the concerned Mangers of the company.
- 11. The supplier should guarantee that the minimum required ingredients as per tender notification/tender conditions are included in the supply of each article. ie, the material supplied should conform to the specification for the same.
- 12. The successful tenderer should furnish security deposit @ 5% of the total purchase value for the due performance of the agreement after acceptance of his tender by the company and before executing agreement.

18. The supplier must also enclose a test report of the material supplied at the time of delivery.

- 19. The Security deposit is liable to be forfeited in the event of any breach of contract by the supplier. In case there is no liability the security deposit will be released after the supply is effected and after getting the non–liability certificate from Managers of estates.
- 20. Special conditions, if any, written on the tender or attached with the tender will not be applicable to the contract unless they are expressly accepted by the company in writing.
- 21. Method of sampling and analysis.

At the time of delivery of the material by the supplier, 3 representative sample of the material shall be drawn(100 gm each) in the presence of the supplier's representative and company's representative. The sample should be labeled as sample No.1, No.2 & No.3 with the signature and date of the supplier's representative and company's representative. The samples will be packed in polythene bags. The 1st sample will be sent for analysis at the approved laboratories by the Company, the 2nd sample is given to the supplier and the 3rd sample will be kept under the safe custody of the company for reanalysis at RRII in case of despute and this result will be binding on both the parties.

- 22. The company reserves the right to get the material tested at appropriate testing agencies to ascertain the quality of the material supplied and the result so analyzed shall be binding on the supplier.
- 23. The tenderer agrees that the time wherever specified is the essence of the contract.
- 24. The price preference for SSI Units as ordered by Government from time to time, if any, will also be extended to such SSI Units who are intending suppliers. Such supplier should produce copy of the certificate proving the status of their firm.

Specificationsfor COPPER OXYCHLORIDE 56% ODP

Copper Oxychloride, employed in the formulation of this material shall conform to BIS 1486 standards.

The spray oil shall not contain less than 70% by volume of unsulphonated residue when tested. The material shall be in the form of free flowing homogenous powder devoid of hard lumps and bluish green in colour. It shall wet readily on mixing with spray oil, providing a suspension suitable for use as to spray.

The copper content percent (m/m) of sample shall be within the tolerance limits indicated below:

Nominal Value, percentage(%): 56Tolerance limit:+ 5 of the nominal value&- 3 of the nominal value.

The actual value of copper content shall be calculated to the second decimal place and then rounded off to the first decimal place.

The suspensibility percentage by mass : 85% minimum

Packing:

The material shall be packed in HDPE woven sacks conforming to IS 8069, 13 kg nominal capacity.
