CONDITIONS ATTACHED TO THE NOTIFICATION FOR REPAIR & MAINTENANCE
OF BOILER IN RUBBER SHEETING FACTORY

1. Tender should submit the tender in the prescribed format which can had from the company or downloaded from the company website after remitting the tender form cost Rs. 600/- + GST 18%.
2. Sealed covers superscribed "OFFER FOR REPAIR & MAINTENANCE OF BOILER AT RSF" should reach the Manager (Factory Complex), Rehabilitation Plantations Ltd., Abhayagiri, Kulathupuzha before 2.30 PM on 12.11.2024. The offers will be opened on the same day at 3.00PM. in the presence of the representatives of intending tenders who are present. Every intending tenderer has to sign each page of tender conditions (**not initials**) in token of having accepted the same.
3. All intending tenderers will have to furnish an Earnest Money Deposit of **2.5%** of the total quoted value in the form of Demand Draft payable at Punalur/NEFT and proof of this should be attached with this offer.
4. Rate quoted should be for "**Repair & Maintenance of Boiler at RSF**" as mentioned in Annexure-I.
5. The tenderers should inspect the boiler before quoting the rate. The rate quoted should be including the supply and installation of spares, painting and any other unforeseen works.
6. GST or other taxes applicable should be shown separately. Otherwise, the rate quoted will be taken as all inclusive.
7. The contractor shall be submitted the copy of valid license from department of Factories and Boilers along with the tender.

8. The rate quoted should be firm for a minimum period of three months from the date of opening or till the Company accepts the same whichever is late. No representations for enhancement of rates once accepted will be considered on any account.
9. The contract will be concluded on issue of workorder by RPL.
10. EMD in respect of tenderer whose offer has been accepted will be retained and adjusted as part of the security deposit for due performance of contract.
11. The tenderers whose offer has been accepted will have to enter into a formal agreement with the company for "**Repair & Maintenance of Boiler at RSF**" as per terms and conditions fixed by the company failing which the EMD is liable to be forfeited and works will be arranged at the risk and cost of the tenderer whose offer is accepted. The **Repair & Maintenance of Boiler at RSF** should be completed within 45 days of the date of confirmation work order.
12. The Managing Director of the company reserves the right to accept or reject any tender without assigning any reason.
13. The successful tenderer should furnish security deposit @ 5% of the total quoted value for the due performance of the agreement after acceptance of tender by the Company and execute agreement as per conditions.
14. Performance guarantee of the boiler should be for a minimum period of one year.
15. Payment of bills will be made as below:
 - (i) 75% after successful completion of R&M (and approval from department of Factories and Boilers) as per the specification of work by the company. Details specified in Annexure-I.
 - (ii) Balance 25% after satisfactory completion of repair and maintenance of Boiler) including approvals from Department of Factories and Boilers and trial runs for a minimum period (period of evaluation) of one month.

The security deposit as mentioned in clause (13) will be released only after the performance guarantee period, depending on no liability report from the concerned official.

16. The R&M works should be completed within the period specified in the work order of the Company. If the contractor fails to complete the work satisfactorily within the specified time, the Company reserves the right to make alternate arrangements from the other source at the risk and loss of the contractor. All expenses incurred in this alternative arrangement including 10% administrative expenses and the difference in cost on such arrangement etc. will be recovered from the defaulting contractor through legal means/revenue recovery proceeding. If the cost incurred in such alternate arrangement is less than that of the rate offered by the defaulted contractor, he will not be eligible for the reduction in rate.
17. The security deposit is liable to be forfeited in the event of any breach of contract by the contractor.
18. Special conditions, if any, written on the tender or attached with the tender will not be applicable to the contract unless they are expressly accepted by the Company in writing.
19. The tenderer whose offer has been accepted should guarantee that the completed work will conform to the work specified in the Annexure-I.
20. The tenderer agrees that the time wherever specified is the essence of the contract.
21. The price preference for SSI/MSME units as ordered by Government, if any, will be extended on production of evidence for the same.
22. All unserviceable items (spares replaced from machines) must be returned to the Factory, Kulathupuzha Estate.
23. The Company reserves the right to get the machinery and system evaluated and certified at appropriate agencies like Rubber Board, Kottayam etc. to ascertain the performance of the system.
24. The tenderer should specify whether it is a manufacturer/dealer/ordinary/MSME supplier.
25. Any dispute arising out of the contract, all suits or other legal proceedings in connection with any of the matter shall be instituted in the courts of Punalur only.


