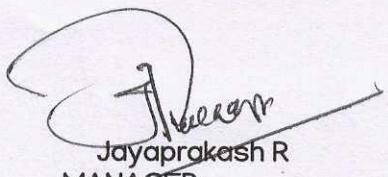

QUOTATION CONDITIONS FOR THE REPAIR AND MAINTENANCE
OF WEIGHING BALANCES

1. Cost of spares should be submitted along with the quotation.
2. Replacement of spares should be done in presence of the Asst.Manager of concerned unit.
3. The new spares used for the replacement must be taken into stock in the central store and unserviceable parts replaced must be handed over to central store of the Estate.
4. Any maintenance or repairing works coming during the period 01.04.2026 to 31.03.2027 should be rectified free of cost as and when required.
